Topic: EB1 EA Approved

I wanted to know what are my chances in EB1 category. I did not apply yet because I am not sure that my profile is as strong as needed.

- 1) PhD from Top Tier University (Top 6) in USA in Electrical and Computer Engineering. Also completed Masters in both ECE and Mathematics from same school. Undergraduate from top school in India.
- 2) 6 journal publications (3 first author, 1 third author) and 45 citations (7 self-citations).
- 3) 3 conference publications including one in which selected for oral presentation (8% acceptance rate).
- 4) Reviewed papers for one journal.
- 5) Currently leading a computer vision group for a startup in USA.
- 1. You need more citation. You need around 110 citations total for EB-1A (the number comes from one of AAO decision), unless you can show that historically your field's publications do not get high citations. AFAIK, low citation is a valid excuse for some fields like maths (and may be physics too). My understanding is that conference publication is given much value by USCIS. So, I am not sure how much that can influence your EB-1A.
- 2. You need to review more articles. A good, safe count is at least 10, preferably from different journals.
- 3. You can claim that you are very important member of your company. That is one criteria of EB-1A, but I was told that unless the company is a big/well-known/MNC type, it is better not to claim that criteria.

So, as others suggested, you are not there yet for EB-1A. You are probably OK for EB-1B, but other than academic types, I have not seen many non-academic types using EB-1B. You may need to research EB-1B a bit. There have been chatter here and there that USCIS is pretty rigorous about EB-1B these days (EB-1B used to be pretty easy in the past)!! If EB-2 backlog is not an issue for you then I say you are pretty well set for EB-2 NIW.

- 1. Your citations, publication record are good enough for EB-1A. I don't think duration of postdoc matters that much. So you are OK on that front too.
- 2. Forget about claiming any criteria because of membership of Sigma xi etc. USCIS these days don't count that as an achievement.
- 3. You may want to **review** a few more papers or get into the editorial board of a publication, just to be on the safe side.

Overall, I would say, you have a pretty good chance for EB-1A. I have seen people getting EB-1A with weaker credentials. At the end, it totally comes down to how well you can argue your case, especially when you are self-petitioning.

Yes, I think USCIS wants the copies of your old passport(s), especially if you have used them to enter the country. They want to see the visa stamps and the entry stamps by the CBP at the port of entry.

If you have lost an old passport, as the comment above suggested, you should have a paper trail documenting the loss. If I am not mistaken, you should preserve all of your old passports and if lost report them.

About the spelling change, my understanding is that the spelling in the first passport is carried over during the renewal. If you want to change the name, the passport authority, changes it noting it on your passport that this was changed to correct a spelling mistake. Do you have something like that? Otherwise, it will be a red flag for USCIS and you don't want USCIS to start suspecting that there may be issues with your ID.

So, as previous comments suggested, get all your paperworks in order. Let your attorney know what issues you have and proceed accordingly.

USCIS exhausted visa numbers for EB-1 by the end of August? Really. When visa numbers will be available again for Eb1A.

No one knows definitively as USCIS did not say anything but there was some chatter on the internet that some lawyers have this info from USCIS or DoS. Few people also noticed that USCIS did not approve any I-485 EB-1 case after August (based on I-485 tracker).

Necessary caveat applies and that's why I said "rumor has it". ... Internet chatter (take with a pinch of salt) and USCIS's apparent random case processing so who knows what is going on. However, if visa numbers were indeed exhausted, they will be available from October, 2012 again as a new year starts from Oct.
