At least to keep you in status, you can file I-140 & I-485 concurrently. At the same time you can

submit your application for EAD & Ap, both of which are free if submitted with your I-485. No premium processing for EB2-NIW is allowed, but once you submit your I-485, you cannot go out of status. Moreover, the USCS will continue to extend your EAD as long as your I-140 is pending as india citizen taking into account your priority date.

Filing for I-140 doesn't stop you from pursuing other immigration options and you take advantage of which ever got approved first.
