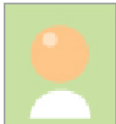

I would really appreciate if you can give me some opinions about my case as I am planning to file under EB1-B. Here are quick facts about my background.

1. PhD from top ten university in US (2006). Post PhD: ~ 3 years of postdoc at top research institutes in US, plus 2 years of research experience in industry. So I have a Total greater than 5.5 years of research experience after PhD.
2. Currently working as a senior scientist in a medium size medical device company (~ 500-700 employees, 1 Billion \$ revenue). My company has at least a dozen PhD researchers in R&D.
3. Publications and Scholarly History: One book chapter (first author), one invited publication, and 10 peer-reviewed journal papers (6 first author). Number of Citations: greater than 150 (I just checked Google scholar, independent citations will be lower, haven't checked that yet). Conference presentations ~ 20. One patent filing (US and WIPO), 4 provisional applications, several provisionals will be converted to patent filings in next 3-4 months.

Mostly I have heard good things about Samira Nichols, but one very bad **review** as well. It seems she may be unresponsive some times.
