Attorney **Chen** did request my RFE letter and original petition letter before accepting my case. After studying the documents she replied with a strategy and the attorney fees. Also consider the fact that accepting a case in the middle, understanding case history, formulating a response strategy and replying to the RFE sometimes require considerable efforts as if preparing a new petition letter. Mine was a complex RFE. She charged reasonable fees and did an outstanding job. The key here is what's in the RFE and how complex it is to respond.

I would certainly recommend contacting Attorney **Chen** and at least obtaining an estimate.

I would certainly recommend attorney **Victoria Chen**. I retained their services for my EB2 NIW RFE response and my NIW petition has been approved within a week of submitting the response. I am an industry professional with two master's degrees. My RFE was very specific and questioned all three prongs of the NIW. I thought I had very slim chance of approval.

When I contacted **Chen Immigration Law** office, attorney **Victoria Chen** herself carefully reviewed my credentials and responded back with a concise note on how to address/tackle each RFE item. She also emailed me a case-specific strategic plan (gathering RFE-related evidence, reference letters, etc.) even though I wasn't under the contract.

When I retained their services, she reviewed and revised additional reference letters and carefully analyzed RFE-related evidence. I am surprised by her knowledge of the NIW requirements and AAO decisions. She prepared an impactful RFE response letter and my case was approved within a week.
